**GENERAL SHOW RULES**

THE SHOW CHAIRMAN AND SHOW COMMITTEE RESERVE THE FINAL AND ABSOLUTE RIGHT TO INTERPRET THESE RULES, SETTLE, AND DETERMINE ALL MATTER, QUESTIONS AND DIFFERENCES IN REGARD THERETO OR OTHERWISE ARISING OUT OF OR CONNECTED WITH, OR INCIDENT TO, THE SCMGA SHOW. ANY EXHIBITO WHO VIOLATESTHE RULES WILL FORFEIT ALL PRIVELEGES AND BE SUBJECT TO SUCH PENALTY AS THE COMMITTEE MAY ORDER.

**ELGILIBILITY: COMPETITION IS OPEN TO ALL GOATS REGISTERED TO THE ABGA,  
INTERNATIONAL, USBGA & CBGA.**

The goat must be registered in the name of the exhibitor and must have been owned by the exhibitor on or before September 1, 2010. Persons showing animals with signed transfers will show as Agents Custom fitters, if different from owner/exhibitor, will register with the Chairman if the owner/exhibitor is not in attendance at the show.

**ENTRIES:** There is no limit on the number of goats that can be entered in a class by an exhibitor. (Youth Showmanship is limited to one goat per child). Application for entry must be on current, official entry forms.

**IDENTIFICATION:** All goats must have a legible permanent ear identification corresponding to the registration certificate. If microchip, owner must provide the reader. Goats without proper will be **DISQUALIFIED**.

**CLASSES:** All goats must be registered purebred, fullblood or percentage boer goats.

**DISQUALIFICATION:** Any goat showing any pronounced defect or abnormality will be barred from the show. Any goat showing visual or questionable signs of swelling will be removed from the show. Any evidence of cosmetic surgical alteration will result in disqualification; artificial coloring will be disqualification. Tattoos inconsistent with registration papers will result in disqualification. Intentional falsification of birth date will result in disqualification.

**ANIMAL HEALTH REQUIREMENTS:** A Veterinary Certificate, valid within 30 days of show, for scabies, footrot, soremouth, CL and any communicable cutaneous fungal disease. **NO EXCEPTIONS!!!!**

**EXHIBITOR BEHAVIOR:** Any exhibitor who interferes with the Judge during their adjudication, or shows any disrespect, may be removed from the show and may withhold prizes won. **NO SMOKING & NO ALLCOHOLIC BEVERAGES ARE PERMITTED IN THE BARNS OR ARENA!!!!!!** Infraction of these rules will be removal from the show and premises.

**LIABILITY:** The exhibitor is liable for any damages his/her goat may incur. The exhibitor is responsible for the safety of his/her goats; the SCMGA assumes no responsibility for such. If any goat is unruly or a threat to the public, the animal will be removed from the show.
